EU4Health programme

- Commission proposal adopted on 28 May 2020
- In July, the European Council reached an agreement on the budget underlying the COVID-19 recovery and the Multiannual Financial Framework.
- That deal, however, represents a substantial cut for the EU4Health Programme.
- The original proposal of €9.4 billion has been reduced to €1.7 billion over the period 2021-2027.
- Negotiations with the Parliament and the Council are ongoing.



GOAL

Survival/improved health of patients affected by rare diseases (RD)

ERNs' OBJECTIVE

Equal access of patients affected by rare diseases to diagnosis and treatment, regardless of their origin and disease

PILLAR 1 ACCESSIBILITY

ACHIEVEMENT 1: Patients know where to go to find support for their health

OBJECTIVE 1

Structure a clear access to services at EU/national/local level

ACTIONS:

Define national referral systems /clear pathways, direct access to the members of the ERNs/access to the national networks/access to the CPMS

PILLAR 2

KNOWLEDGE GENERATION & PROFESSIONAL CAPACITY BUILDING

ACHIEVEMENT 2: Healthcare professionals have access to the right knowledge and expertise to diagnose, manage or treat patients.

OBJECTIVE 2

Provide clinicians with expertise and clinical tools

ACTIONS:

Clinical practice guidelines
Clinical Decision Support Tool
Access to the right knowledge

On the Joint Action

- Under the leadership of Member States
- Grants for co-financed actions, awarded without calls for proposals
- Member States' authorities invited to nominate one competent authority responsible for implementing the action on their behalf. In addition, "affiliated entities" also eligible to participate.
- The competent authorities to identify and select the civil society organisations active at EU level as collaborating partners and/or to participate in advisory structures.





On the Joint Action

Example of timeline (in 2020):

- Invitation to MS to nominate competent authorities (CAs): March 2020, deadline May 2020
- Invitation to nominated CAs to submit proposals: June 2020, deadline October 2020
- Evaluation, Grant agreement signature, Start of the Joint Action: Q1 2021
- Duration of the Joint Action: usually 2-3 years.

What is needed for successful Joint Action?

- To identify interested Member States whose CAs will actively contribute
- To identify the right working areas (work packages)
- To identify the right expected results/deliverables of the action





Potential areas of action

- Starting point: 2019 Statement of the ERN BoMS on Integration of the ERNs to MS healthcare systems
- Potential areas:
 - Governance framework for ERNs integration to the national systems
 - Patient care pathways
 - Referral systems to the ERNs
 - Awareness raising on ERNs at national level
 - Sustainability of the ERN model at HCP level
